



# STATE DEMOLITION NOMINATED SUPERVISOR TRAINING, 2022

To meet state demolition licensing requirements, you must successfully complete nationally accredited training for eligibility to work as a nominated supervisor for a demolition licence holder. The regulator has selected units from the Certificate III & Certificate IV in Demolition qualifications and they are packaged as a skill-set to meet the requirements of approved training. On successful completion of this skillset you will be issued with a Statement of Attainment (SOA).
